## Clarivate Discontinues *IJERPH* and *JRFM* Coverage in Web of Science

On March 15, 2023, we received note that Clarivate has discontinued coverage of *IJERPH* and *JRFM* in Web of Science as of 13 and 22 February respectively. Clarivate found that both journals failed the **Content Relevance criterion**, highlighting publications that were deemed outside the scope of the journal, and not to do with quality of the publications. On 31 March 2023, we formally appealed the decision to discontinue *IJERPH* in Web of Science.

Clarivate periodically evaluates journals indexed in their **collections**, and any journals that no longer meet their criteria are removed from coverage. Unfortunately, publishers are not informed about the evaluation process until its completion.

## Predatory Conferences

**Predatory conferences** (sometimes referred to as bogus / fake conferences or predatory meetings) pretend to be legitimate scientific conferences, but their purpose is to profit from registration fees **without any qualitative contribution** to the scientific community. This unfair practice often abuses the need to participate in international conferences of beginning scientists.

Predatory conferences take two forms:

1. The conference **does not take place** at all
  - The conference is announced on its website and often by unsolicited e-mails, but after paying the registration fee, all communication ends and the event never takes place.
2. The conference **takes place, but in inadequate quality**
  - The event actually takes place, however, its quality does not meet well-established standards. It is often accompanied by a weak organization, changes in the programme, missing presenters and too general presentations without a logical connection between them.

## Identifying Predatory Conferences

There are a number of ways to identify predatory conferences. Identifying these conferences is important for you as a researcher and for others in the [academic publishing](#) field.

- Is the conference included in the list of known predatory conferences?
- However, do not assume a conference as not being predatory if it does not show up in the list.
- Did professional societies and other well-established organizations organize this conference? Be wary of organizations with overly generic names and avoid extremely large conferences that combine various fields into one conference.
- Are there various options to contact the conference organizers? Most legitimate organizations do not use free email accounts and have websites with “.edu” addresses.
- How long does it take for the acceptance of the paper? Most predatory conferences promise a quick turnaround time for papers to lure in unsuspecting academics.
- Does the conference have awards for researchers and papers? Be wary of conferences that promise a large number of rewards.
- Do the conference organizers promise paper publication? Most legitimate conferences do not guarantee publication.
- Is there a geographic variety in terms of the editorial board? If all editors came from the same place, then this could be a sign of a predatory conference.
- Do the editors have any academic information presented about themselves?
- Is there evidence to suggest that the review members or editors are not educationally qualified to conduct the peer review process?

#### Abstract:

Altmetric indicators for several years have been more and more often seen on publishing platforms and websites, as well as in bibliographic databases - e.g. in the Scopus database. These indicators are an element of scientific communication and although they may raise doubts and questions: are they reliable, what do they really serve, what do they inform about, and whether everyone should know and use them, e.g. by tweeting, posting information about publications at the ResearchGate website. Currently many publishers (Taylor & Francis included) offer information about altmetric and bibliometric indices, i.e. citations in WoS CC, Scopus. The article presents systematized information on these indicators together with examples of the reasons for their occurrence, also among specialists conducting research in the field of electromagnetism and occupational health and safety. Even if they are wondering what the next metrics are for and how they can be helpful. (Why do specialists in electromagnetism and OSH need altmetric indicators...).



